2023 Policy Address – making Hong Kong a better place for all

A better living environment, quality education, young people realising their potential and the elderly taken care of Address on 25 October, the Chief Executive of the Hong Kong Special Administrative Region (HKSAR), Mr John Lee, set out a range of initiatives to revive the economy, create opportunities and ensure long-term prosperity and stability of Hong Kong.

Entitled "A Vibrant Economy for a Caring Community" the policy address outlined the HKSAR Government's policy focus on upholding "One Country, Two Systems", and strengthening the economy to improve people's livelihoods. It stated the Government's aspiration to create a cohesive and caring community, with a vibrant economy where everyone can enjoy life. The Government will continue, it says, enhancing governance systems and foster a stronger sense of national identity and patriotism in the community.

The Government also announced plans to set up a Digital Policy Office to formulate policies on digital government, data governance and information technology.

Revitalising the economy

The Policy Address outlined a series of initiatives to revitalise the economy and create opportunities for the development of priority sectors. The Government plans to boost the economy and drive growth through infrastructural creation, moving ahead with land and transport development projects to expand economic capacity.

To boost the city's strength as a global

hub for commerce and finance, the Government plans to promote a "headquarters economy" to attract more Mainland and overseas enterprises and talents to the city. A mechanism will be introduced to facilitate the re-domiciliation of companies to Hong Kong, in particular those with a business focus in the Asia-Pacific region.

A New Industrialisation Development Office will be created to promote new industrialisation and support strategic enterprises to develop their businesses in Hong Kong. A HK\$10-billion (around GBP 1.03 billion or EUR 1.17 billion) New Industrialisation Acceleration Scheme will also be launched to provide financial assistance for enterprises in the fields of life and health technologies, artificial intelligence and data science, advanced manufacturing, and new energy technologies.

With tourism a pillar industry for Hong Kong, the Government will formulate a development blueprint for tourism, to be published next year. To promote arts and culture, a new Cultural and Creative Industries Development Agency will be formed with the aim of developing arts, culture and creative industries. The Government will also inject HK\$4.3-billion (around GBP 442.5 million or EUR 505.2 million) into the Film Development Fund and the CreateSmart Initiative to provide incentives for attracting private sector capital and expanding new markets.

Economy

Hong Kong ranks well globally

Hong Kong continues to rank highly among the world's freest economies, and is recognised in new research as being one of the most competitive economies in the world.

In the Economic Freedom of the World 2023 Annual Report, published by the Fraser Institute, Hong Kong was placed second globally, and among the five areas of assessment:

- Top in "Freedom to trade internationally"
- Third globally in "Regulation"
- Year-on-Year improvement scores and rankings in "Size of government" and "Sound money".

In the latest World Competitiveness Yearbook (2023), from the International Institute for Management Development, Hong Kong was ranked seventh globally and among competitiveness factors:

- Second globally in "Government efficiency"
- Top ranking in "Business legislation"
- In the top five for "Tax policy", "International investment", "International trade" and "Technological infrastructure".
- Improved ranking in "Infrastructure"

In the latest Global Financial Centres Index (published in September) Hong Kong maintained fourth place globally with a notable overall rating increase. The data is compiled by the Z/Yen from the United Kingdom and the China Development Institute from Shenzhen and assesses 121 global centres.



Hong Kong's ranking has risen to fourth in:

- Business environment
- Human capital
- Financial sector development
- Reputational and General

A Government spokesman said this reflects recognition of Hong Kong's sustained strength and robustness as an international financial centre in the post-COVID era.

Finally, in the 2023 issue of The Global Innovation Index, published by the World Intellectual Property Organization, the Shenzhen-Hong Kong-Guangzhou science and technology cluster has been ranked second, globally, for four consecutive years. Hong Kong's ranking:

- Remains fifth in Asia
- Is 17th globally (among 132 economies)
- Performed "well" in the Innovation Input sub-index (eighth globally)
- Improved to 24th in the "Innovation Output" sub-index.

2023 Policy Address

Noting that Hong Kong has among the world's longest life expectancies and coupled with a low birth-rate, the Policy Address announced various initiatives to create a more family-friendly environment and encourage more couples to have children, emphasising land and housing as a key priority.

National identity and culture

The Government will continue to roll out various programmes and initiatives to enhance national identity and promote Chinese culture and history.

"As we stay united and embrace our diversity, I firmly believe that we will be able to build a better Hong Kong together," Mr Lee concluded.

Multi-entry visas to the Mainland announced in the 2023 Policy Address

As announced in the 2023 Policy Address, starting from 26 October 2023, foreign staff of companies registered in Hong Kong may apply with the Chinese Visa Application Service Center (www.visaforchina.cn/HKG2_EN/) in Wan Chai, Hong Kong for "multiple-entry visas" to the Mainland, which last for two years or more, and enjoy priority processing. For those non-Chinese Hong Kong Permanent Residents, they can apply for "multiple-entry visas" valid for up to five years.

The introduction of the visa facilitation measure positively responded to the aspirations of foreign chambers of commerce and the business community in Hong Kong for ease of northbound travel which would further facilitate their active participation in the Greater Bay Area development.



Raising the flag on 26 years



A flag-raising ceremony and reception were held to celebrate the 26th anniversary of establishment of the HKSAR.

The HKSAR Chief Executive, Mr John Lee, addressed the audience at the Hong Kong Convention and Exhibition Centre on 1 July which also marked the first anniversary of the current-term Government.

"A year ago, President Xi Jinping visited Hong Kong and delivered an important speech in which he made it clear that 'One Country, Two Systems' has been tested repeatedly in practice, so there is no reason for us to change such a good policy, and we must adhere to it in the long run," Mr Lee remarked.

"President Xi also put forward 'four musts' and 'four proposals', which now serve as the basis of the governance blueprint for me and the HKSAR Government. With these central ideas in mind, I have built a pragmatic team that adopts a result-oriented approach to unite the community and build a better Hong Kong," added Mr Lee.

As part of a post-pandemic European tour the HKSAR Financial Secretary, Mr Paul Chan, visited London to brief political and business communities in Europe about the latest situation and developments of Hong Kong, as well as its unique role and status.

Business boost

Arriving in London, Mr Chan attended a dinner hosted by the Hong Kong Trade Development Council which welcomed around 400 leaders and professionals from various UK sectors.

He took the opportunity to remark that Hong Kong will actively consolidate and enhance its status as an international financial centre, and raise the competitiveness and attractiveness of the securities and bond markets, asset and wealth management centre, offshore renminbi hub, and alike.

Packed agenda

On a busy second day in London, Mr Chan met The CityUK Leadership Council, an industry-led body representing UK-based financial services. He pointed out that Hong Kong is the ideal gateway and platform for UK's financial as well as asset and wealth management businesses for opening up the Mainland's and Asian markets, and he hoped to strengthen mutual collaboration.

During a Hong Kong Association luncheon, Mr Chan gave a speech to more than 120 guests from the political and business communities in the UK. He said that Hong Kong is pursuing high-quality development at full speed, led by the dual engines of financial services and innovation and technology, and is determined to become the international green tech and green finance centre.

In the afternoon, Mr Chan met with the Governor of the Bank of England, Mr Andrew Bailey, to exchange views on financial regulation, interest rates, inflationary trends and the global economy.

There was also time to call on the Chargé d'Affaires of the Chinese Embassy, Minister Yang Xiaoguang.

On his third day in London, Mr Chan visited biopharmaceutical company AstraZeneca to meet senior management and learn about the drug research and development as well as expansion plans.

During the meeting Mr Chan pointed out that his government actively seeks to attract cutting-edge enterprises to set up or expand their business in Hong Kong. In early October, the Office for Attracting Enterprises (OASES) signed an agreement with the first batch of strategic enterprises, including AstraZeneca, setting up or expanding their businesses in Hong Kong to jointly promote the development of the innovation and technology (I&T) ecosystem of Hong Kong.

Then, Mr Chan attended a roundtable luncheon held by the China-Britain Business Council, and met representatives of British enterprises that have business or plan to set up business in the Mainland and Hong Kong.

In the afternoon, Mr Chan visited the Royal College of Art and toured a number of applied research projects of AiDLab and learned about how artificial intelligence could empower fashion design, interior design, textile materials analysis and preserving traditional crafts. Mr Chan also found time to meet a

The HKSAR Chief Executive, Mr John Lee, welcomed over 400 senior representatives from Mainland and foreign companies at an Invest Hong Kong reception on 15 June. He thanked them for their lasting confidence in Hong Kong's business environment and called on them to continue using the city's global advantage to expand their business worldwide.

Mr Lee said that under the "One Country, Two Systems" principle, Hong Kong has the distinctive advantages of the strong support of the motherland and the close connections with the world. He added that Hong Kong is indeed the only city in the world that converges both the China advantage and the global advantage.

"With the full support of the Central Government, as well as the plentiful opportunities under such national strategies as the National 14th Five-Year Plan, the Guangdong-Hong Kong-Macao Greater Bay Area development and the Belt and Road Initiative, Hong Kong is the best place for investors to start and expand their business operations," Mr Lee said.

The HKSAR Secretary for Commerce and Economic Development, Mr Algernon Yau, also attended and joined Mr Lee to offer a toast to the guests.

••• Finance Fintech leading global role



One of the annual flagship events of the Financial Services and the Treasury Bureau, the Hong Kong FinTech Week 2023, featured more than 500 speakers, 650 exhibitors and tens of thousands of participants from over 90 economies, in person or virtually.

Organised jointly by the Hong Kong Monetary Authority and InvestHK, it offers global participants opportunities to build partnerships, exchange ideas and share their fintech journeys.

At the main conference, the HKSAR Secretary for Financial Services and the Treasury, Mr Christopher Hui, announced three major initiatives to foster co-development of fintech and real economy.

These include launching a new Integrated Fund Platform, welcoming cross-boundary Chinese Yuan applications to benefit inbound and outbound visitors between the Mainland and Hong Kong, and promoting real economy-related applications and innovations by the Virtual Assets and Web3.0 sector, as well as further development of the regulatory framework.

"I am glad to learn that our initiatives are well supported. Looking ahead, the Government will join hands with regulators and major market players to press ahead with the initiatives, with a view to injecting new energy to our ever-growing fintech ecosystem," Mr Hui said.

Enticing UK engineers to Hong Kong

A one-week long visit to the UK by the Hong Kong Institute of Engineers (HKIE) highlighted the promising outlook for engineering practitioners in Hong Kong.

The first day of the visit programme included visits to sister institutions in the UK before a hybrid conference in Westminster which welcomed distinguished speakers from the Institution of Civil Engineers, the Chartered Institution of Building Services Engineers, the Chartered Institution of Water and Environmental Management, and the Institution of Mechanical Engineers. They shared their views and experiences on Climate-resilience Infrastructure Development.

A forum for UK Engineering Small and Medium-sized Enterprises was supported by the London ETO and Hong Kong Trade Development Council. The gathering aimed to facilitate knowledge exchange between engineering SMEs. An expert panel comprised experts from the HKIE with diverse backgrounds and extensive professional experience. They gave exclusive insights into Hong Kong's engineering profession's latest developments and forthcoming opportunities. Attendees heard about the Hong Kong Government's latest initiatives supporting engineering and infrastructure projects.

Visiting Manchester on Day Two, there was a cocktail reception for delegates before meetings and social gatherings.



These allowed time for an exchange with local engineers, students and entrepreneurs, members of sister institutions, and HKIE members living in the city.

The visit ended back in London with a technical look at the capital's Elizabeth Line operation before a farewell reception for invited guests.

Tai Hang Fire Dragon Dance



On three nights during the Mid-Autumn Festival, at the end of September, the Tai Hang Fire Dragon Dance wends along the backstreets of Tai Hang in Causeway Bay.

The ceremony features a 67-metre dragon adorned with thousands of burning joss sticks and hundreds of performers, and follows a tradition running over a century.

Each autumn, the quaint neighbourhood of Tai Hang came alive as a glowing dragon – carried by over 300 performers – dances through the streets.

This fascinating tradition of Hong Kong dates back to the 19th century, when residents of the then small Hakka village combated a plague with a fire dragon dance, accompanied by roaring gongs and drums.

Today, the Tai Hang Fire Dragon Dance is officially listed as a National Intangible Cultural Heritage, and continues to attract crowds for the blazing spectacle each year.

Flying High at Asia's Top Airport

Named as Asia's Leading Airport in the latest World Travel Awards, celebrations took place at Hong Kong International Airport which has witnessed huge investment to create new facilities and services.

The airport has seen the commissioning of a new 3 800m-long third runway coupled with the expansion of Terminal 2, construction of T2 Concourse, a new baggage-handling system and automated people-mover, all scheduled for completion in 2024.

At an event celebrating the airport's silver anniversary in July, the HKSAR Chief Executive, Mr John Lee, said, "We all experience the good and happy steps when we go through the airport. That would not be possible without the commitment, devotion and the excellent work of each one of the members of the whole Hong Kong airport family."




Careers

More medics heading to Hong Kong

Hong Kong's success in attracting doctors trained abroad is gaining momentum as the Global Healthcare Talent Convergence Programme welcomes overseas healthcare professionals.

Among them is Dr Strathan Dino Chun who has returned to his native Hong Kong after 14 years of medical training and practice in the UK. "I wanted to return to serve Hong Kong", said the ophthalmologist who works in the New Territories West.

Dr Fung Hoi Yin also joined the Hospital Authority in May after nine years in Britain. She is now a resident in family medicine and primary healthcare in the New Territories West.

Between April and September more than 130 non-locally trained doctors were hired; the majority of them are from the UK and Australia. They will be assigned to various specialities

including those with the most acute shortage.

There are plans for collaborations with professional bodies and global institutions to promote the advantages of practising medicine in Hong Kong.

Qualifications

The fourth batch of overseas medical qualifications to be recognised in Hong Kong has been published and will also help to swell the influx of trained medics.

The Special Registration Committee has now recommended 100 medical qualifications for recognition. They are now pressing ahead with the assessment of other non-local medical programmes that fulfil the stipulated criteria in order to determine their next batch of recognised medical qualifications.

Hong Kong's engineering prowess was acknowledged at recent global award ceremonies. The city's metro system came top for comfort, convenience and sustainability to win the prestigious International Association of Public Transport award with its "Smart and

Inclusive Journey Programme". The MTR system has recently enjoyed an extension at Admiralty Station which boasts an innovative vertical circulation design and 34 new escalators. The project received

an innovative vertical circulation design and 34 new escalators. The project received Special Recognition during the Union Internationale des Transports Publics (UITP) Global Public Transport Summit in Barcelona.

The awards are selected by an international panel of industry experts and recognise the most ambitious and innovative public transport projects around the world.

The UK's Institution of Civil Engineers gave multiple awards to the Development Bureau of the HKSAR Government for achievements by its works departments.

Belt and Road summit draws unprecedented attendance

With around 6 000 attendees and over a hundred overseas and Mainland delegations to the eighth Belt and Road Summit, the event saw record attendance.

Marking the tenth anniversary of the Belt and Road Initiative (B&RI), this was first fully-physical gathering since the pandemic and welcomed delegates including overseas government officials and prominent international business leaders. Together they reviewed the development of the Initiative since 2013, and investigated investment, business and trade opportunities.

Under the theme "Prospering on a Decade of Collaboration", this year's Summit highlighted Hong Kong's role as the functional platform for the B&RI, and to assist enterprises and professional services in exploring business opportunities, in particular those arising from emerging markets such as the Middle East and the Association of Southeast Asian Nations markets.

Vice Premier of the State Council, Mr Ding Xuexiang, gave a video keynote speech at the opening session. Deputy Director of the Hong Kong and Macao Affairs Office of the State Council, and the Director of the Liaison Office of the Central People's Government in the HKSAR, Mr Zheng Yanxiong, also delivered a special address.



Speaking at the opening session, the HKSAR Chief Executive, Mr John Lee, highlighted that more than 150 countries and over 30 international organisations have signed co-operation agreements with China in collective pursuit of the B&RI, setting in motion more than 3 000 co-operation projects and nearly US\$1 trillion in investment. Noting that Hong Kong is determined to embrace the vast promise of the B&RI, Mr Lee said that the HKSAR Government is redoubling its efforts for Hong Kong to serve as the functional platform for the Belt and Road.

Asian Games close in style with the best ever medal haul for Hong Kong



There was a spectacular closing to the Hangzhou Asian Games in October as Team Hong Kong, China achieved their best-ever results. They came away with a total of 53 medals: eight Golds, 16 Silvers and 29 Bronzes.

The Men's Bridge Team won the eighth Gold in Men's Team Final, tying the record of eight Golds at the last Asian Games in Jakarta, Indonesia.

The HKSAR Chief Executive, Mr John Lee, extended his congratulations to the athletes on their outstanding achievements, commending their perseverance and distinguished performance.

Mr Lee said, "This is the largest Hong Kong delegation ever to participate in the Asian Games. The results were very encouraging. Their spirit of hard work has won everyone's applause and support."

The Hong Kong athletes won gold medals in rowing, fencing, swimming, rugby, golf, cycling and bridge. The Hong Kong men's football team also made a historic appearance in the semi-finals of the Asian Games, arousing the passion of fans across Hong Kong. The HKSAR Chief Secretary for Administration, Mr Chan Kwok-ki, attended the Closing Ceremony at the Hangzhou Olympic Sports Centre Stadium. He said that the Hong Kong, China Delegation has made great efforts in striving for excellence at the Games, bringing glory to the city and pride to all Hong Kong citizens. He also believed that all Hong Kong citizens would be proud of the country's success in presenting to the world a great event that is distinctly Chinese, uniquely Asian and spectacular.

The HKSAR Government has pledged to continue to fully support Hong Kong athletes and the development of sports in Hong Kong. In 2023-24 it has provided some HK\$1.18 billion (around GBP 121.4 million or EUR 138.6 million) in funding to carry out work relating to supporting elite sports.
